#### FEEDING DIRECTIONS

Feed Supreme 16 with forage to growing calves. Feed 1.5 pounds per 100 pounds of body weight to supply 4.55 mg of Diflubenzuron. The dosage of ClariFly Premix is proportional to the animal's body weight and must be offered daily throughout the entire fly season. The following table provides the feeding rate. Feed continuously to calves (excluding veal calves) to provide 0.14 to 1.0 mg monensin/lb body weight/day, depending on severity of challenge, up to 200 mg monensin/head/day.

CAUTION: Do not allow horses or other equines access to feed containing monensin. Ingestion of monensin by horses has been fatal. Monensin medicated cattle and goat feeds are safe for use in cattle and goats only. Consumption by unapproved species may result in toxic reactions. Do not exceed the levels of monensin recommended in the feeding directions, as reduced average daily gains may result. If feed refusals containing monensin are fed to other groups of cattle, the concentration of monensin in the refusals and amount of refusals fed should be taken into consideration to prevent monensin overdosing. This feed contains supplemental cooper. Do not feed to sheep. Clarifly may causes moderate eye irritation. Avoid contact with eyes or clothing. Wear protective eye wear. Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet.
